

COOKIE POLICY OF VBS WEB APP

This document provides you (“the data subject”) with detailed information about the use of cookies (and similar technologies), how they are used by the “VolleyBallSystem” Platform (“VBS” or “App”) and how to manage them.

Please note that on VBS we only use cookies of a technical nature, which are necessary to ensure, for example, the correct identification of the person following the authentication process or used to ensure the normal navigation and use of the site or the functionalities of the e-commerce. This document provides you (“the data subject”) with detailed information about the use of cookies (and similar technologies), and how they are used by the App. Please note that the use of such cookies of a technical nature and the carrying out of the processing connected to them, does not require, under the applicable regulation, your consent.

Controller

The App is managed by **Sport System S.r.l.s.**, which acts as Controller of the data issued by users who browse it or who have purchased the services provided through this web application. The use of cookies and related technologies by Sport System S.r.l.s., headquartered in Corso Guglielmo Pepe n. 74 - 88069 Squillace (CZ), C.F./P.Iva 03809120797 Tel: 3281086256, E-mail: vbssportsystem@gmail.com (“Company”), falls within the privacy policy of the company, in accordance with the provisions of the EU Regulation 2016/679, the D. Lgs 196/03 Code on the protection of personal data (Privacy Code) and the Provision of 10 June 2021 “Guidelines cookies and other tracking tools” of the Italian Privacy Guarantor.

What are cookies

Cookies are short pieces of text (letters and/or numbers) that allow a website to store on the client (browser, e.g. Internet Explorer, Chrome, Firefox, Opera...) information to be reused during the same visit to the site (session cookies) or later, even at a distance of days. (cookie persistenti). Cookies are stored, based on the user’s preferences, by the individual browser on the specific device used (computer, tablet, smartphone). Cookies, usually present in the browsers of users in a very large number and sometimes also with characteristics of large time persistence, are used for different purposes: performing computer authentications, tracking sessions, storing information about specific configurations concerning users accessing the site, etc. Generally, **cookies** can be divided into:

- **Technical cookies** (or session cookies), typically indispensable for the proper functioning of a website and used to manage various services related to the website (such as a login or access to reserved functions on the site). The duration of cookies is strictly limited to the working session or they can use a longer duration to remember the visitor's choices (ad esempio la lingua del sito, i colori, le dimensioni dei test ecc.). Disabling strictly necessary cookies may compromise the experience of using and browsing the website or make the website completely unusable.
- **Analysis cookies** (or Analytics cookies), similar to technical cookies where they are used directly by the site operator to collect anonymous information, in aggregate form, about the number of users and how they visit the site itself. Disabling these cookies can be done without any loss of functionality.
- **Profiling and marketing cookies** (not operating on this site). These are permanent cookies used to identify (anonymously and not) the different preferences made by the user while browsing the Site and to improve his or her navigation experience. Types of cookies used by this Site

On this Site only technical cookies are used, such as, for example, technical session (or browsing and functional) cookies, as necessary for the proper functioning of the Site.

These cookies, always sent by our domain, are necessary to properly display the App and in relation to the technical services offered, will therefore always be used and sent, unless the User changes the settings in his browser (alterando la visualizzazione delle pagine del Portale).

In this regard, it is recalled that some operations on the Site could not be carried out without the use of these cookies, as necessary to be able to access the site and continue the operations exercised in it. For example, access to reserved areas of the Site and the activities that may be carried out there would be much more complex to carry out and less secure without the presence of cookies that allow us to identify you and maintain your identification within the framework of the session.

"Technical" cookies may also be used in the absence of the consent of the data subject. Among other things, the same European body that brings together all the guaranteed privacy authorities of the various Member States (the so-called "Article 29 Group") has clarified that cookies are cookies for which it is not necessary to obtain the prior and informed consent of the user:

- cookies with data compiled by the user (session identifier), the duration of a session or persistent cookies limited to a few hours in certain cases;
- Authentication cookies, used for the purpose of authenticated services, of the duration of a session;
- user-centric security cookies, used to detect authentication abuses, for a limited persistent duration;
- session cookies for media players, such as "flash" player cookies, of the duration of a session;
- Session cookies for load balancing, the duration of a session;
- persistent cookies for the customization of the user interface, the duration of a session (or slightly more);
- cookies for sharing content using third-party social plug-ins, for members of a social network that have logged in.

Therefore, our website does NOT in any way use third-party cookies, marketing, profiling or tracking cookies.

The technical cookies used by this site are temporary and are deleted by the browser once you leave the site or when the browser is closed or when you log out.
